Power of Attorney for Customs and Forwarding Agent

Hereby constitutes and appoints: Bennett International Transport LLC, its heirs and assigns, its officers, employees and/or specifically authorized agents, to act for and on its behalf as a true and lawful agent and attorney of the grantor for and in the name, place and stead of said grantor, from this date, in the United State (the "territory") either in writing, electronically, or by other authorized means, to:

Make, endorse, sign, declare, or swear to any customs entry, withdrawal, declaration, certificate, bill of lading, carnet, shipper's export declaration, commercial invoice, insurance certificate, draft or any other document (s) required by law or regulation in connection with the exportation, importation or transportation of any merchandise in or through the customs territory, shipped or consigned by or to said grantor:

Perform any act or condition which may be required by law or regulation of the Department of Commerce, Department of treasury, Census Bureau or any other governmental agency in connection with such merchandise deliverable to or from said grantor: to receive or ship any merchandise:

Make endorsements on bill of lading conferring authority to transfer title; make entry or collect drawback; and to make, sign, declare, or swear to any statement or certificate required by law or regulation for drawback purposes, regardless of whether such document is intended for filing with Customs;

Sign, seal, and deliver for any as the act of said grantor any bond required by law or regulation in connection with the entry or withdrawal of imported merchandise or merchandise exported with or without benefit of drawback or in connection with the entry, clearance, lading, unloading or navigation of any vessel or other means of conveyance owned or operated by said grantor, and any and all bonds which may be voluntarily given and accepted under applicable laws and regulations, consignee's owner's declaration provided for in section 485, Tariff Act of 1930, as amended or affidavits or statements in connection with the entry of merchandise:

Sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the transportation, importation, exportation, entering, clearing, lading, unloading, or operation of any vessel or other means of conveyance owned or operated by the said grantor;

Authorize other Customs Brokers duly licensed within the territory to act as grantor's agent; to receive, endorse and collect checks issued for Customs duty refunds in grantor's name drawn on the treasurer of the United States or otherwise on behalf of grantor, if the grantor is a nonresident of the Territory, to accept service of process on behalf of the grantor. Grantor acknowledges receipt of ; Bennett International Transport LLC. Terms and Conditions of Service governing all transactions between the Parties. And, we waive the right to receive direct billing (s) from the appointed customs broker (s) of Bennett International Transport LLC.

And generally transact Customs business, including filling of claims or protests under Section 514 of the Tariff Act of 1930, or pursuant to other laws of the Territories, in which said grantor is or may be concerned or interested and which may properly be transacted or performed by agent and attorney;

Giving to said agent and attorney full power and authority to do anything whatever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all the that the said agent and attorney shall lawfully do by virtue of these presents;

The Export/Importer hereby certified that all statements and information contained in the documentation provided to the Customs House Broker/Forwarding Agent relating to the exportation/importation are true and correct. Furthermore, the Exporter/Importer understand that civil and criminal penalties may be imposed for making false or fraudulent statements or for the violation of any United State laws or regulations on an exportation/importation.

This power of attorney is to remain in full force and effect until revocation in writing is duly given and received by the Port Director of Customs. (if the donor of this power of attorney is partnership or LLP, the said power shall in no case have any force or effect in the Territory after the expiration of two (2) years from the date of its execution). If Grantor is a LLC, the signatory certifies that he/she has full authority to execute this power on behalf of the Grantor. If Grantor is a Partnership or LLP, a copy of the partnership agreement must be submitted along with this form.

Pursuant to the Customs Regulations 111.29(b), if you are the importer of the record, payment to the broker will not relieve you of liability for Customs charges (duties, taxes, or other debts owed Customs) in the event the charges are not paid by the broker. Therefore, if you pay by check, customs charges may be paid with a separate check made payable to the U.S. Customs Service, which shall be delivered to Customs by the broker. Importers who wish to utilize this procedure must contact our office in advance to arrange timely receipt of duty checks.

Sign and date below to further authorize; Bennett International Transport LLC.; its heirs and assigns to prepare " Shipper's Security endorsements" on behalf of your company, in compliance with current FAA regulations. We will agree to do so only if authorized to do so in writing, and only if absolutely certain of the contents of all shipments.
